### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical personnel.

<b>General information</b>	The severity of the symptoms described will vary dependent on the concentration and the length of exposure.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

**Suitable extinguishing media** The product is not flammable. Use fire-extinguishing media suitable for the surrounding fire. Use foam, carbon dioxide, dry powder or water fog to extinguish.

### 5.3. Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. **Methods for cleaning up** Clear up spills immediately and dispose of waste safely. Avoid generation and spreading of dust. Collect powder using special dust vacuum cleaner with particle filter or carefully sweep into suitable waste disposal containers and seal securely. If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Label the containers containing waste and contaminated materials and remove from the area as soon as possible. Flush contaminated area with plenty of water. Wash thoroughly after dealing with a spillage. Leave small quantities to evaporate, if safe to do so.

### Appropriate engineering controls
